ORDER

In terms of provisions laid down in Sub-Rule (9) & (10) of Rule 4 of the West Bengal School Service Commission (Mutual Transfer) Rules, 2012 issued vide Notification No. 348-SE/S/IS-06/2012 dated 21.02.2012 by the Government of West Bengal in School Education Department in connection with Mutual Transfer of an incumbent with another incumbent from reciprocal places of their posting read with, No : 687/SE/S/IS-08/16 Dated : 24.05.2016 of School Education Department and on the basis of the resolution adopted by the Hearing Committee on 22-Dec-2016 in presence of the The District Inspector of Schools (SE), Murshidabad and Secretary/President/Administrator Headmaster/Headmistress/Teacher-In-Charge, NIMTITA G.D. INSTITUTION (H.S.) and Secretary/President/Administrator Headmaster/Headmistress/Teacher-In-Charge, GOPINATHPUR HIGH SCHOOL as well as both the concerned applicants, the West Bengal Central School Service Commission after having been satisfied, hereby recommends to allow the Mutual Transfer between the incumbents as mentioned below of which the incumbent mentioned against Sl. No. 1 should be released first by the Secretary/Administrator NIMTITA G.D. INSTITUTION (H.S.) to enable him/her to join in the new place of posting within 3 (three) days from the date of his/her release and the incumbent mentioned against Sl. No. 2, the counterpart of incumbent mentioned at Sl. No. 1 should be released by the Secretary/Administrator GOPINATHPUR HIGH SCHOOL after joining of the incumbent mentioned at Sl. No. 1 to enable him/her to join in place of incumbent mentioned at Sl. No. 1 within 3 (three) days from the date of his/her release.
